Chairman, Wayne Klingman, Chairman called the meeting to order. Chairman Klingman opened with a moment of silence in the passing of Kenneth Catherman, township roadmaster.

- Wayne Klingman made a motion to not adopt the Burning Ordinance as printed, seconded by Robert Goss, Jr. All in favor. Motion passed.
- Discussion regarding snow removal policing. The Sheriff could be called regarding violations. Wayne made a motion to adopt Ordinance 2021-01, Snow Emergency, seconded by Robert Goss, Jr. All in favor. Motion passed.
- Robert Goss, Jr. made a motion to purchase signs for snow emergency routes this summer, we will need 6 signs, seconded by Wayne Klingman. All in favor. Motion passed.
- Discussion on the Solar property concerns. Concerns if companies go bankrupt in the future, who will remove panels and the possibility of erosion issues. Wayne

Klingman made a motion to adopt Ordinance 02-2021, Amendment to the Zoning Ordinance to Provide for Accessory Solar Energy Systems and Principal Solar Energy Systems, seconded by Robert Goss, Jr. All in favor. Motion passed.
